#### THE DILEMMA: TO VACCINATE OR NOT TO VACCINATE

The Open Door Center and other companies and health care facilities are faced with the dilemma of vaccination mandates issued in recent emergency regulations effective November 5, 2021. OSHA and the Center for Medicaid and Medicare Services, commonly referred to as CMS, have issued joint emergency standards regarding covid vaccination requirements. CMS is stating that any agency participating in Medicaid or Medicare programs must require their staff to be fully vaccinated or in the process of becoming fully vaccinated by January 4, 2022. OSHA is instructing all companies employing over 100 staff must require them to become vaccinated by January 4, 2022. These two federal agencies impact the Open Door Center because most of the Center's funding comes from CMS and because the Center employs more than one hundred people. CMS can withhold funding while OSHA can fine the agency up to \$14,000 per person for noncompliance of this emergency regulation that is effective November 5, 2021. Non-compliance is not only expensive but prohibitive due to the expense of ignoring the mandates.

There is language in both mandates that allows for "hardship" exclusions. These hardships fall into two categories: religious or medical. Religious hardships are defined by EOEC's Compliance Manual on Religious Discrimination or Title VII of the Civil Rights Act of 1964. However, the agencies require that employees who qualify for either hardship test weekly and have additional infection prevention measures such as masks, social distancing, hand hygiene, etc. Religious hardships are not granted as a means to avoid vaccination.

CMS requires facilities to allow for exemptions to staff who have a recognized medical condition for which the vaccines are contraindicated but are accommodated through the Americans with Disabilities Act. CMS states that exemptions could be appropriate in limited circumstances, but staff must legally meet the definition under the ADA or Title VII of the Civil Rights Act of 1964. The agency must have documentation of clinical contraindications to the COVID-19 vaccinations for staff with a medical hardship that is signed and dated by a licensed practitioner, preferably their primary care physician. The documentation must also name the vaccinations that are problematic and the basis for the contraindication. Both agencies note that research states that vaccination is the best prevention for Covid 19 and its variants.



CMS will work directly with the surveying agency to conduct onsite reviews to assess vaccination status of staff and compliance by all facilities. Open Door Center is surveyed annually by the referenced "surveying agency". OSHA will require documentation or complete onsite evaluations of the agency.

The dilemma arises when that agency becomes involved with assessing the status of the unvaccinated staff in meeting the requirement of both or either CMS and OSHA. The agency must have evidence of documentation of timely testing by an approved testing agency. The testing results must be accessible for the agency for proof and to provide appropriate staffing level. According to the mandates the cost of the testing is not the responsibility of the agency. It is almost impossible for the agency to assure even a small number of unvaccinated staff are meeting the requirements established by these two federal agencies. The cost of staff time for verification of each staff's testing is almost prohibitive. It is also difficult to prove that the staff is not trying to evade the requirements without researching the various documents pertaining to hardships. This is fortified by the scientific proven fact that vaccination is the best protection against Covid-19 and its variants. The Covid-19 vaccines can keep you from getting and spreading the virus and help keep you from getting seriously ill even if you do get it. Getting vaccinated protects people around you and it protects the people you serve.
